The attention of the officers noted in the address entry is invited to the references cited and they are informed that, vide reference 1st cited, the Government have issued the Andhra Pradesh Regulation and Penalisation of Building Constructed unauthorisedly and in Deviation to the Sanctioned Plan Rules, 2019. The Government have extended the time limit from time to time for disposal of all pending applications filed under this scheme and finally extended the time limit till 31.12.2020 vide reference 2nd cited.

2. In the reference 3rd cited, the DTCP, AP has informed that, there are still applications pending for want of NOC from Andhra Pradesh Disaster Response and Fire Services Department and for submission of all required particulars and payment of Penal amount and requested for extension of time limit to dispose all pending applications.

3. After careful examination of the matter, the Government hereby extend the prescribed time limit upto 31.03.2022, for disposing all pending applications filed under Building Penalization Scheme, formulated vide G.O.1st cited. All the officers noted in the address entry, shall take further necessary action in the matter accordingly.
